Commercial, industrial and residential premises including hospitals, hotels, and food preparation areas.	Cockroaches	10 mL per L water.	Inspect premises thoroughly and locate cockroach harbourages. Apply directly into cockroach harbourages or areas where cockroaches traverse, such as cracks and crevices, away from where it is likely to be removed by cleaning programs. Numerous smaller placements will provide faster control, especially for German cockroach control. Apply behind sinks, stoves, and pipes paying particular attention to all cracks and crevices which might contain cockroaches. Repeat treatments when pests begin to reappear.

DIRECTIONS FOR USE:

MIXING

Invert the ATTRATHOR container several times to ensure thorough mixing of the concentrate. Half fill the spray tank with water and then add the required quantity of ATTRATHOR. Stir and then top up the spray tank to the required volume. The use of this product in a tank mix with other insecticides is not recommended as the behaviour and efficacy of the product may be affected. Ensure equipment is clean.

GENERAL INSTRUCTIONS

ATTRATHOR is a contact insecticide used for the control of cockroaches. It is used in a wide range of situations, including restaurants, food manufacturing, processing and storage plants, supermarkets, hotels, hospitals, domestic and other similar situations.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT

Highly toxic to fish and aquatic organisms. Do NOT apply to areas where surface water is present. Rinse waters and runoff from treated areas MUST be prevented from entering drains or waterways. Do NOT contaminate streams, rivers or waterways with the chemical or used containers. Dangerous to bees.

PRECAUTION

Before spraying, remove animals and pets from the areas to be treated. Cover or remove any open food and water containers. Cover or remove (as applicable) fish ponds, aquariums, etc. before spraying.

STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well-ventilated area. Do NOT store for prolonged periods in direct sunlight. Triple or (preferably) pressure rinse containers before disposal. Add rinsings to the spray tank. Do not dispose of undiluted chemicals on site.

If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots in compliance with relevant government regulations. Do not burn empty containers or product.

SAFETY DIRECTIONS

When opening the container, donning and using the spray wear cotton overalls, buttoned to the neck and wrist (or equivalent clothing) and elbow length chemical resistant gloves. Wash hands after use. After each day's use, wash gloves and contaminated clothing.
